ARM / Baylor Notifies Members About Dividend

Governor Kasich en-dorsed action proposed by BWC Administrator/CEO Steve Buehrer to request that the BWC Board of Directors authorize a one-time dividend of \$1 billion. Each employer's dividend will reflect 56% of what they were billed during the last policy period (July 1, 2011 to June 30, 2012 for private employers; January 1, 2011 to December 31, 2011 for public taxing districts).

Private employers must have an up-to-date policy and be in an active, reinstated or debtor in possession status as of April 1, 2013, in order to be eligible for the dividend. Public-taxing districts must have an up-to-date policy and be in an active or reinstated status as of March 31, 2013 to be eligible.

Safety training required by the BWC in order to be eligible for rebates on premium paid during the current policy year must be completed by June 30, 2013. Contact our workers' compensation program administrator Bruce Baylor at 440-546-7600 or bbaylor@baylorwc.com with any questions.
