Alternative Risk Management Offers Help with Your Workers Compensation Needs

Ohio private state-funded employer payroll report true-up process starts July 1st under new prospective billing with Ohio Bureau of Workers Compensation. Payroll true-up reports are due to the Ohio BWC no later than August 15th, 2016.

With the transition to prospective billing, the Ohio BWC now require employers to reconcile their actual payroll for the prior policy year and reconcile any differences in premium paid. The payroll true-up allows us to calculate your premium accurately. Even if your payroll for the year matches the estimate you provided, or you had zero payroll, you must complete a true-up report.
