Ohio Offers Several New Grants for Businesses

The State of Ohio has offered 4 New Business Grant Programs that may be helpful to some of our Kenmore Chamber members. Each portal opened June 29th, and it is important to know that you can only apply for one program. These are first come, first served grants. You can apply by going to https://businesshelp.ohio.gov/.

Food and Beverage Establishment Grant

This program will provide grants of \$10,000, \$20,000, or \$30,000 to restaurants, bars, coffee shops, and other food and drinking businesses. The amount of the grant to eligible businesses will be determined by the business' loss of revenue in 2020.

Eligible Businesses: The business must have at least one physical location in Ohio that has been in operation since at least Dec. 1, 2019, including food service contractors; caterers; mobile food services; drinking places, such as bars, taverns, nightclubs, etc.; full-service restaurants; limited-service restaurants; coffee shops; cafeterias; buffets; snack and nonalcoholic beverage bars; and businesses that do not otherwise qualify for the Entertainment Venue Grant because they earn more than 50% of their revenue from the sale of food and/or beverages. The business must have experienced at least a 10% reduction in sales/revenue in 2020 at one or more Ohio locations as a result of COVID-19. The business must be in good standing with the Ohio Secretary of State, the Ohio Department of Taxation, and any other governmental entity charged with regulating the business.

Entertainment Venue Grant

This program will provide grants of \$10,000, \$20,000, or \$30,000 to theaters, music venues, spectator sports venues, museums, and other entertainment venues. The amount of individual grants to eligible businesses will be determined by the business' loss of revenue in 2020.

Eligible Businesses: The business must have at least one physical location in Ohio that has been in operation since at least Dec. 1, 2019. Eligible entities include theaters and dinner theaters; movie theaters; indoor and/ or outdoor music venues; comedy clubs; concert halls; spectator sports venues; museums; arts centers/galleries; historical sites; zoos and botanical gardens; amusement and theme parks; family fun centers; trampoline and adventure parks; arcades; golf courses; sports centers; skiing facilities; marinas; recreational sports centers; and bowling centers. The business must have experienced at least a 10% reduction in sales/revenue in 2020 at one or more Ohio locations as a result of COVID-19. The business must be in good standing with the Ohio Secretary of State, the Ohio Department of Taxation, and any other governmental entity charged with regulating the business. The business cannot have earned 50% or more of its annual revenue from the sale of food or beverages, but may be eligible for the Food and Beverage Establishment Grant program.

Lodging Grants

This program will provide grants of \$10,000, \$20,000, or \$30,000 to hotels, motels, and bed and breakfast operations. The amount of individual grants to eligible businesses will be determined by the business' decline in occupancy rate in 2020.

Eligible businesses: The business must have at least one Ohio location that has been in operation since at least Dec. 1, 2019, and must have a hotel/motel license from the Ohio Department of Commerce. Businesses can be a hotel, motel, or bed and breakfast. The business must have experienced at least a 10% reduction in occupancy in 2020 as a result of COVID-19. The business must be in good standing with the Ohio Secretary of State, the Ohio Department of Taxation, and any other governmental entity charged with regulating the business.

NEW Small Business Grants (for businesses started in 2020)

This program will provide grants of \$10,000 to small businesses that were established between Jan. 1, 2020, through Dec. 31, 2020.

Eligible Businesses: The business must be a for-profit entity that started operations between Jan. 1, 2020, and Dec. 31, 2020, and that has at least two and no more than 25 Ohio employees paid via W2 wages as of Jan. 1, 2021. The business must have a physical location in Ohio and experienced revenue loss or unplanned costs because of the COVID-19 pandemic. The business must be in good standing with the Ohio Secretary of State, the Ohio Department of Taxation, and any other governmental entity charged with regulating the business.
